Salinan Tribe of Monterey and San Luis Obispo Counties March 16, 2024 General Meeting Minutes Meeting began: 11:50am

- I. Old Business:
- A. Approval of September 17, 2023 General Meeting minutes. Robert moved to approve, Don Jr. Seconded the motion. Motion passed.

B. Federal Recognition Update-Michael Woody reported on the current federal recognition work that he is doing and the progress of it. Section B and Section C of Federal Recognition, the political and community sections of the package, didn't have the level of proof that the Federal Government was looking for. Kenny and Michael have been working to find documents that will string the time periods together and allow us to show continuity by the standards of the Fed. They have made a great deal of progress and are on track for Federal Recognition. The San Luis Obispo Historical Society has been very helpful in tracking down this information. He explained why it was a lot easier for a Salinan to claim to be white than to recognize their Indian ancestry. Michael reminded everyone that at the beginning of each monthly business meeting, it is open to the general council to come with their input for concerns and ideas. Also, he reminded everyone that the closed part of the monthly business meeting is under a confidentiality agreement. As always if you have questions please call him, email him or come to his house and he will gladly go over federal recognition with you.

C. Monitoring Update-Robert Piatti- "we all wish that there were more people here, and the meetings are very important". As of March 15th, anyone who is employed by the tribe as a monitor will be going through a payroll service. In May there will be an opportunity for monitors to receive training. Robert, Mary and Patti will be putting together the training. He then went on to report on several jobs that we are and have recently been monitoring. Right now, it is really slow and is definitely seasonal. We currently have 8 monitors on the list and a few large projects coming up. The Wind Farm has had our representation at their meetings. They are being sued right now. Robert reported on some of the offshore meetings. Don reported about how a subcommittee is setting up. Several questions came from the general council. Robert, John, and Don answered them. 3 entities right now are running the wind farms. Several tribes are working together and giving input. The wind farms are currently preparing to do a coast wide survey from Half Moon Bay to the Channel Islands. (Sonar, deep water testing and more) Johnny encouraged everyone to write letters. He reminded the General Council that not even the Executive Council all agree on the Wind Farms. We have written letters and sent them in individually. The General Council is encouraged to do so as well. Kenny has put that in the newsletter and can do so again. Kenny reminded us that only 25% of the general council open their newsletters. We offered to the general council several ways to communicate and will do a better job at communicating to the general council. Dee Dee is concerned that we are not responding to requests in a timely and respectful manner. It was agreed by all that the council will do more to communicate via email, the website, general meetings, and our individual contacts as well as the newsletter. It is being requested by the general council that our Facebook site be removed. Eddie talked about establishing trust between the Executive Council and the General Council. Great discussion ensued. Robert invited everyone to reach out to their family members and spread the word. Barbara feels that the northern territory gets left out a lot.
